<p>Guidance on how to respond to a pupil or staff member displaying symptoms of the virus is at https://www.gov.uk/government/collections/guidance-for-schools-coronavirus-covid-19</p>		AO
<p>Any pupil, staff or other adult displaying symptoms or having tested positive in the last 7 days should not come into school and alert the school immediately</p>		SB
<p>Anyone developing the symptoms (a new, continuous cough or a high temperature, or has a loss of, or change in, their normal sense of taste or smell) during the school day will be sent home. They will be advised to follow 'stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection', which sets out that they must self-isolate for at least 7 days and should arrange to have a test to see if they have coronavirus (COVID-19). Other members of their household (including any siblings) should self-isolate for 14 days from when the symptomatic person first had symptoms. If the test is negative, they should return to school</p>		SB
<p>If a child is awaiting collection, they will be moved, if possible, to a room where they can be isolated behind a closed door with appropriate adult supervision if required. Ideally, a window should be opened for ventilation. If it is not possible to isolate them, they will move to an area which is at least 2 metres away from other people. PPE must be worn by staff caring for the child while they await collection if a distance of 2 metres cannot be maintained (such as for a very young child or a child with complex needs). More information on PPE use can be found in the safe working in education, childcare and children's social care settings, including the use of personal protective equipment (PPE) guidance.</p>		SB
<p>Any member of staff working in a different location should inform the school immediately if there is outbreak of the virus in that organisation or establishment</p>		All
<p>Any members of staff who have helped someone with symptoms and any pupils who have been in close contact with them do not need to go home to self-isolate unless they develop symptoms themselves (in which case, they should arrange a test) or if the symptomatic person subsequently tests positive (see below) or they have been requested to do so by NHS Test and Trace.</p>		All

<ol style="list-style-type: none"> The government is relaxing its shielding measures from 1st August and expects that most members of staff can return to the workplace, particularly should the local transmission rate remain low and the government advice been implemented If staff have significant risk factors, a discussion will take place and the needs of the staff member will be accommodated where possible; e.g. strict social distancing from other adults and as much social distancing from children as possible. Support from PCC HR team and Occupational Health may be sought. <p>5. The organisation of lunch and playtimes will be pod based (see internal timetable and rota)</p> <p>6. The organisation of wraparound care will also be pod based: initially, EY and KS1 will have half of the hall each (with taped of spaces, separate resources, etc) and KS2 will share the music room in the same way. As numbers grow, N/R will be in BB classroom; Y1/2 in LB classroom; Y3/4 in the intervention room; Y5/6 in the hut</p> <p>7. Sharing of resources will be pod based</p> <p>8. The majority of staff will be in pods. A few staff will work with children from different pods; e.g. school leaders, SENCO, ELSA, PPA teachers. Further precautions will be taken to reduce the risk to these staff members</p> <p>9. Interventions groups will mainly be in pod classrooms. Should they need other areas, Y3/4 and Y5/6 will use the areas in which they are based for breakfast and after-school club, i.e. Y3/4 in the intervention room and Y5/6 in the hut; and Y1/2 in the hall.</p> <p>10. <u>Control measures</u>		Who
<ol style="list-style-type: none"> Children should wash their hands every time they return to the classroom with bowls inside or outside the classrooms (downstairs classrooms) or in the corridors (upstairs classrooms) Ensure entrances to classrooms are clear Remove excess furniture to increase space When possible, every classroom should have windows and internal doors open to maximise ventilation Class teachers to determine layout of furniture, keeping government advice in mind. No children should be directly facing each other closer than 1m though arrangements other than rows are permitted Children in KS1 and KS2 should sit in the same place each day Class Rules created with the children and frequently reviewed; these must include: handwashing expectations, the 'Catch It, Kill It, Bin It' approach, instructions on how to line up, use of toilet, moving around the classroom and school Lessons planned for individual or paired work (not group work in first instance) Where possible staff to be at front or side or back of room at least 1m away, particularly when talking to the class 		CTs

<p>1. Pods will be allocated specific toilets to use and will be pod based (this may mean not using the nearest toilet). <p>1. Staggered drop off and pick up times for different pods – see above</p> <p>2. Children to be dropped off by gate; no parents of children in Y1-6 should be inside the school gates</p> <p>3. Children come straight to classroom, markers outside the classrooms for the children to wait 1 metre apart before washing their hands upon entering the classroom</p> <p>4. Face coverings are discouraged in school. If not wearing a covering causes a child considerable anxiety, SLT / SENCo / ELSA will determine school if one can be worn.</p> <p>5. If a mask is worn on way to school it must not be left in school but taken home by the parents</p> <p>6. Children should not bring unnecessary equipment – sandwich boxes and book bags if necessary but no back-packs.</p> <p>7. Parents asked to arrive on time and then leave the immediate school area quickly to allow parents dropping children off to be able to maintain social distancing – specific information will be sent on newsletters</p> <p>8. Only packed lunches will be available from Caterlink. All packed lunches will be eaten in classrooms or in the playgrounds. 6. Children will stay in their classrooms only being allowed out for play, lunch break, to go to the toilet, specific interventions (although most of these will be in the classroom), first aid that is serious enough to require first aid delivered from the medical room. 2. One boy and one girl going to toilet at one time, with hygiene rules reinforced 3. Corridors to be kept clear 4. Yellow tape to be placed in the centre of the corridors and the wider 'Y3/4' staircase, with 'Keep Left' signs. No children or staff to pass each other on the narrow 'Y5/6' staircases. 5. If they do (e.g. PPA cover teachers take away to mark) they should be left in a sealed box for at least 72 hours before being handled. 5. Reading books will be boxed for distribution to classroom book corners. Most books will be banded books with a few relevant non-fiction and children will be able to take up to two books home. Boxes will stay in one classroom for a half term before being cleaned and delivered to the next classroom 6. Books will be chosen on a Monday. Children will return book to a class Quarantine Box. On Mondays (after at least 72 hours) these books will be returned to the book corners for children to select 7. Homework should not be in books - as much electronic as possible or on paper that is left for 72 hours before checking 8. All surfaces left clear at end of the day for easy cleaning 9. Tables, door handles and other surfaces cleaned every day 10. Outdoor playground equipment will be allocated to each pod 11.
